2019-20 Year End Treasurer's Report

Dear Membership,

WASCOE'S financial situation looks good. We will collect approximately \$10,800 in dues this year. We sold enough raffle tickets to cover the \$2,000 in cash prizes that we awarded last week. Our stipend from NASCOE for sending delegates to the National Convention last August in Manhattan, Kansas was \$672 and the stipend for Shelby Niskanen participating in NASCOE's Aspiring Leader Development Program last October in Dallas, Texas was \$524.

Our largest expenditure is our quarterly dues to NASCOE. \$55 of every member's annual dues goes to NASCOE. Through the third quarter we have paid NASCOE \$7,018 in dues. Reimbursements to our delegates to the National Convention and Midwest Area Rally are our next largest expense, which was approximately \$3,150.

Due to the recent COVID-19 situation, the Board of Directors made two votes: one, to cancel our annual convention, and two, to use the proceeds from the raffle to help fund our scholarships for this year only due to not having our auction, which traditionally funds our scholarship program. Unfortunately, this means we only have approximately \$2,000 for this year's scholarship awards which is far short of the \$3250 we award annually.

One question the Board of Directors often hear is, "what are member's dues used towards?"

The Board of Directors work hard to be fiscally responsible with your money. When making decisions, we consider options and ideas which allow us to reach our goals and keep expenses as low as possible.

In order to operate, your dues are used to cover our annual costs. Board of Directors meeting expenses, teleconference meeting services, employee & family memorials, annual Board of Directors elections, and website fees are a few of these expenses.

Our membership committee mails out "welcome packets" to newly hired employees. When possible, we coordinate with the State Office new employee orientation sessions to provide lunch while informing new employees of the mission of WASCOE/NASCOE and available benefits.

Our annual convention is an event that we tailor you, our membership, to be informative as well as enjoyable and entertaining. We arrange for a delicious meal during the banquet and offer a hospitality room of refreshments to enjoy while mingling with your FSA friends! We use this opportunity to award and recognize employees who contribute to their service to agriculture, their communities, and to FSA.

WASCOE also supports the Midwest Area and NASCOE by providing a donation (a \$100 limit) to both of these scholarship auctions. We also support the host state of the National Convention and their fundraising efforts by purchasing \$500 in raffle tickets. We send delegates to the Midwest Area Rally and the National Convention. Being a delegate is a great opportunity to represent Wisconsin. The information presented at these events really makes you aware of what the leadership of NASCOE is doing and the issues they are addressing that face us. You see the passion your fellow members have towards FSA County Office employees and how much our work is valued in helping our farmers.

NASCOE uses dues collected from every state to provide stipends for states' delegates to the National Convention as well as offering stipends for other events such as the Leadership Development program. These events provide a great opportunity for members' development into NASCOE leaders. NASCOE also has their own operating expenses as well. The Executive Board meets to discuss and determine which issues County Office employees are facing need to be a priority for the Negotiations Committee.

I hope this provides a brief understanding of what your dues are used for and the opportunities of being a delegate or representing Wisconsin at a NASCOE conference or event.
