### Brandi Bender - Director - Area 3

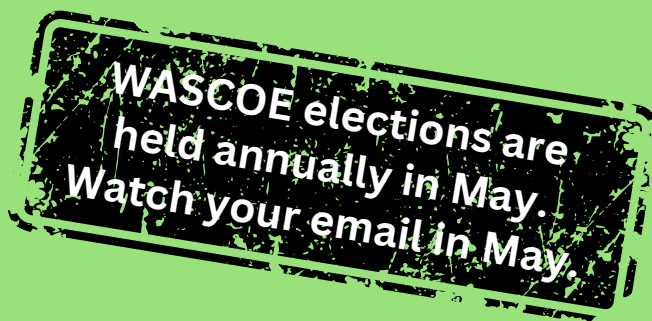

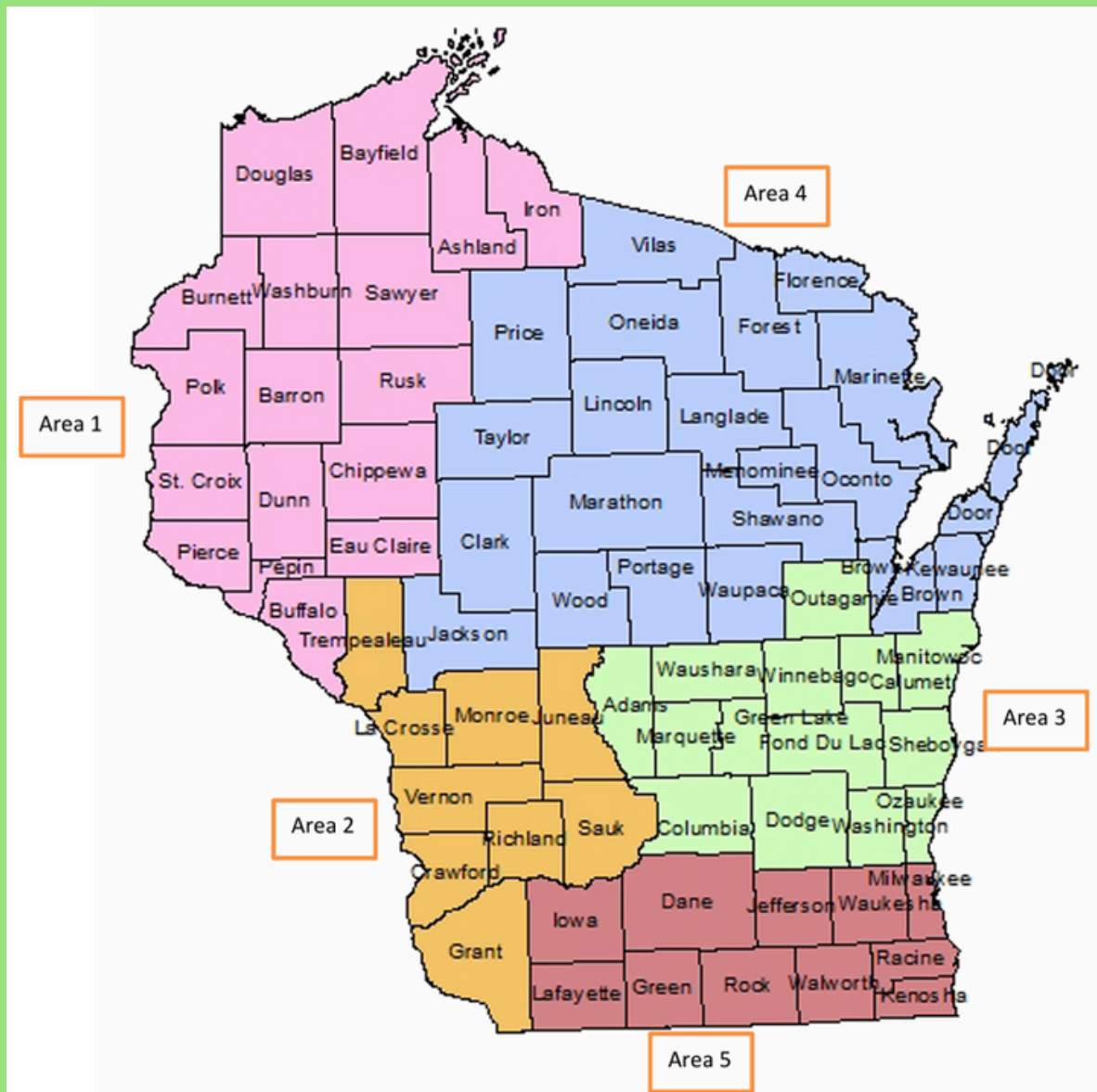
